It is with great pleasure that I write this letter of recommendation on behalf of Torey Culbertson, a friend and colleague I have had the pleasure of knowing for the past 7 years. I met Torey when he and I were graduate students at the University of La Verne in La Verne, California. I at the time was an elementary school teacher, Torey a high school Social Studies teacher. Although we did not teach similar subjects or similar grades, the reasoning behind why we were in the field of education became evident through class and personal discussion. Torey and I both shared a similar interest in some of the major tenets behind liberatory theology.

Liberatory theology in my case was the belief that the attainment of liberation through literacy could change ones in subjugated and oppressive positions in society. This idea, for the poor and dispossessed, was a philosophy fueled by the work of Paulo Freire, an educational theorist who conducted work with illiterate adults in San Paulo, Brazil. In contrast, liberation theology for Torey, stemmed from the Jeffersonian idea that citizens can make intelligent and informed decisions at the polls if they are literate about the government and its political process.

We were both educators attempting to instill in our students the importance of being literate and informed citizens. Torey and I discussed the many activities and discussions he and his students shared regarding the history and intention of the founding fathers in regards to due process and democracy. His passion and interest in the subject matter was evident in the long hours he would place in the preparation for his coursework and the interest he took in individual students.



Through their writing and class discussion, it was obvious that his students were critically investigating the United States in regards to public policy initiatives and their intent. They became motivated about the subject matter and were eager to actively participate in class discussion and activities. The result was that students began to realize that if they were informed, they could be active participants in the political process in the United States; one of the many intentions devised by the writers of the Constitution. These behaviors and this form of critical inquiry, as witnessed by myself an educator as well, is an event that typically does not occur on high school campuses of today. I was impressed by the stories, activities and discussions presented.

I am at present a Professor at the City University of New York at Queens College and am no longer a classroom teacher. However, those remembrances of our conversations and discussions as the University of La Verne with Torey create a longing for me to return to the classroom. However, I am comfortable with the fact that there are individuals such as Torey as high school classroom teachers.

I understand Torey as an exemplary individual with the capability of succeeding in any endeavor of his choosing. He has proven to his students, and the field of education; excellence and dedication.




